# Residential Metering – Installations

Costs for meter installations are the responsibility of the property owner. GEID has arranged for a bulk meter discount through Corix Water Products, 750 Finns Road in Kelowna. **Due to the required meter specifications, only Corix Water Products will be supplying GEID meters.** 

We recommend that you make arrangements for your meter installation prior to October 1, 2015 to avoid delays in your installation.

You have **three options** to choose from for the installation of the meter and remote reader:



1. Arrange for CORIX (phone 250-765-3826) to complete the meter installation. CORIX advises that you can also leave a voicemail with your Name, Address and Phone Number, and they will contact you

about scheduling a meter installation.

2. Arrange for a certified plumber to complete the meter installation. Meters must be purchased at Corix Water Products and they will provide a GEID **Residential Meter Installation Handout.** If your contractor did not get a Residential Meter Handout, you can also visit the GEID website: www.glenmoreellison.com and click on the Regulations/Residential *Metering* tabs so that you can download a complete meter installation package which includes a list of plumbing installers, meter installation specifications, and a meter inspection form for your contractor to review. There is also a 'Frequently Asked Questions' section on the website. Meter installation packages and FAQs are also available at the GEID Office.

#### **RATE REVIEW & 2016 RATES**

GEID and their consultant, Econics, who are specialists in utility rate setting, recently completed a comprehensive Rate Review to determine metered rates for 2016. to instructions in Option 2 about purchasing and installation of meter.

Customers choosing options 2 or 3 will need to contact the GEID office to arrange for an inspection once the meter installation is complete.

In order to access the metered rate for January 2016, meters must be installed by December 29, 2015. (Initial reads will be done on December 30 and 31.) Accounts that have meters installed

after December 29 will be pro-rated to the date of installation. If you haven't heard from your meter installer, call them again as many contractors/ plumbers are backlogged.



**ODD/EVEN WATERING REGULATIONS:** Watering is permitted according to civic addresses on odd or even days, and during specific hours, depending on whether underground or above-ground systems are used. These regulations apply to all outdoor sprinkling. See our website for more information. New Due Dates Announced!

# **New Quarterly Due Dates for Residential Billing**

First Payment due April 30th, 2016 – for January, February, March 2016

Residential categories will continue to be billed quarterly, however to accommodate the timing required to read the meters, new due dates for 2016 have been determined. For billing purposes, meters will be read on the 15th of each month and bills will be mailed near the end of the quarter.

Unmetered properties will continue to be billed quarterly until a meter is installed.

The new Quarterly due dates will be: APRIL 30, JULY 31, OCTOBER 31 AND JANUARY 31 (2017). There will be NO January 31, 2016 due date as customers will be making payments on Dec 1st, 2015 for the 4th Quarter Period of October, November & December 2015. Your first payment for 2016 will be due on April 30, 2016. Payments received after April 30, 2016 will be subject to a 10% penalty.

ATTN PRE-AUTHORIZED PAYMENT CUSTOMERS: Your payments will be automatically withdrawn on the new due dates listed above. Your first automatic payment for 2016 will be April 30, 2016. Your original Pre-Authorized agreement form remains valid as we are still billing on a Quarterly Basis. Your bill will still be mailed or emailed to you as usual.

Please note that Commercial categories will continue to be billed monthly. Commercial General Irrigation properties will be billed monthly for the 6 months during the irrigation season. Residential General Irrigation will be billed quarterly along with the Residential (domestic) invoice.

## **Irrigation Valves**

GEID expects that the seasonal irrigation services will be turned OFF over a twoweek period in October, focusing on Ellison/Dry Valley from Oct. 1-7th, followed by Glenmore from Oct 6-10th. Visit the District's website and tab to 'Irrigation Valves' for updates to this schedule.

### **Assessment Notices**

The 2015 Assessment Notices accompanying this newsletter contain important information concerning each property. This information includes the legal description of the property, the name of the owner on title, and GEID's assessment of the property. All property owners, by law, must receive these notices. If the assessment is correct, no action is required. If corrections are required, or if you have any questions, do not hesitate to contact the office.

If there is a dispute to the assessment that cannot be resolved, the dispute will be addressed at the Court of Revision to be held on Thursday, September 24, 2015, at 7:00 pm.

Appeal applications for the Court of Revision must be received by 4:00 pm on Wednesday, September 23, 2015.

# Project Update: UV Treatment Facility at McKinley Reservoir

The Board of Trustees is pleased to advise that the second stage of water quality improvements for the Glenmore/McKinley areas has begun. GEID is constructing an Ultra-Violet Treatment Facility and Bypass at McKinley Reservoir, which is expected to be completed in early 2016. Once completed, GEID Staff will be working with Interior Health to re-assess the Water Quality Advisory that is currently attached to GEID's water supply.

### **Main Line Flushing**

Water main flushing is carried out each Spring and Fall to ensure that the freshest water is provided to GEID customers. The Fall 2015 flushing is scheduled for September 29th through to November 5th. Flushing dates for the various roads and areas are updated on the District website at www.glenmoreellison.com on a regular basis.

Water pressure fluctuations and discoloration in the water will occur during flushing. Check your water prior to use and avoid doing laundry or using hot water while flushing is underway in your area. If discoloration is experienced, run the cold water tap until the water runs clear.



# **Private Infrastructure Flushing**

Infrastructure systems not owned by the District, including within multi-family complexes, schools, plazas and other properties, are deemed as private and must also be flushed to ensure that the freshest water is delivered to the end user. This flushing should be conducted immediately AFTER the District has completed its mainline flushing.

The Fire Department expects hydrants to be regularly flushed to eliminate any deposits which could affect the pumping capacity

of private hydrants. Private hydrant permits are available at no charge and are required from GEID prior to any private hydrant flushing.

### **After Hour Call-Outs**

After-hour service calls are EMERGENCY call-outs and are billed at a rate of \$150 per call-out to the property owner.
